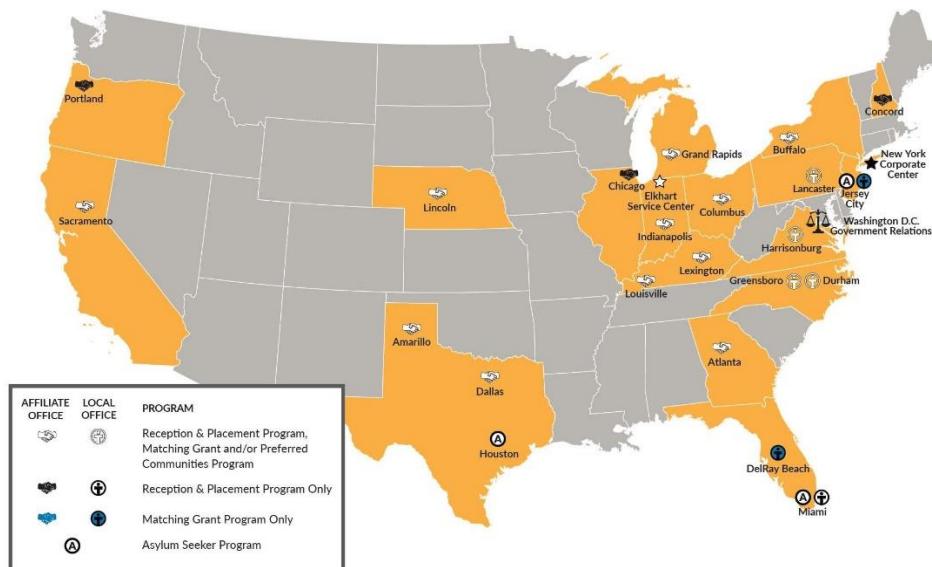
### What's the difference between SIV and refugee status?

### Where and when will SIVs be resettled?

There are not defined timelines of when individuals will leave bases to be resettled. Both government and NGO partners are involved on bases to process and vet individuals as quickly as possible so they are able to resettle in their new communities. As CWS and local affiliate offices hear more information about arrivals we will communicate with community members.

### **How are you handling COVID concerns?**

Arriving Afghans are tested for COVID-19 upon arrival to the country. They are tested again on day 5 at a military base and offered the COVID-19 vaccine as a part of the medical processing. Local affiliate office procedures vary depending on community needs and include practices to keep volunteers, clients, and staff safe during the continuing pandemic.

### **Will the national refugee resettlement cap play any role in how many Afghan nationals can arrive in the US?**

Refugee and SIV capacities are separate from one another, so we do not expect the refugee cap to impact Afghan arrivals at this time. In addition to the 62,500 refugees approved to be resettled in FY 2021, RAs have been approved to resettle 12,000 SIVs in FY 21. The Afghan Parolee Support Program capacity is separate from the refugee and SIV capacities.
