FEMA Disaster Recovery Centers

[DRC Locator \(fema.gov\)](#): temporary offices set up after a disaster to provide assistance with the application process, answer questions about your application, and help you submit information to FEMA. Text DRC to 43362. Check for updates.

FEMA Transitional Sheltering Assistance

You must have a FEMA application number and approval from FEMA to participate in the Transitional Sheltering Assistance (TSA) program. [Use the hotel locator to find a participating hotel.](#)

If you have questions about TSA or need help locating a hotel, you may also call the FEMA Helpline at 1-800-621-3362, 7 a.m. to 10 p.m. (in your time zone), 7 days a week. Hours may be longer during high disaster activity.

If you use a video relay service (VRS), captioned telephone (CTS), or other service, give FEMA your number for that service.

Disaster Assistance Program Hotline for FEMA Assistance: (800) 276-9511

- Answers questions about FEMA.
- Helps identify the types of FEMA assistance for which a survivor might be eligible.
- Explains the terms of each survivor's specific FEMA determination letter.
- Clarifies the documentation FEMA needs from the survivor in order to review and deliver their financial assistance.
- Drafts and compiles FEMA appeals on behalf of the survivor.
- SBP can help with contractor estimates for home repair appeals.
- Submits compiled appeals to FEMA.

Department of Homeland Security

"ICE and CBP do not conduct immigration enforcement activities at protected areas such as along evacuation routes, sites used for sheltering or the distribution of emergency supplies, food or water, or registration sites for disaster-related assistance or the reunification of families and loved ones. At the request of FEMA or local and state authorities, ICE and CBP may help conduct search and rescue, air traffic deconfliction and public

safety missions. ICE and CBP provide emergency assistance to individuals regardless of their immigration status."

Information for Immigrants and Undocumented Persons about FEMA

["All individuals, regardless of citizenship and immigration status,](#) affected by a major disaster may be eligible for crisis counseling assistance, disaster legal services, disaster case management, disaster supplemental nutrition assistance program and other non-monetary, in-kind emergency disaster-relief programs. These include medical care, shelter, food and water."

["Households who don't meet citizenship or immigration status at the time of a FEMA application can still apply if:](#)

- The parent or legal guardian of a minor child who is a U.S. citizen, non-citizen national or qualified non-citizen applies for assistance on behalf of the minor child, so long as they live in the same household.
- The parent or legal guardian must apply as the co-applicant, and the minor child must be under age 18 at the time the disaster occurred.

Emergency Prescription Assistance Program

[EPAP](#) helps individuals in a federally identified disaster area who do not have insurance to access prescription drugs, vaccinations, medical supplies, and equipment. Find out which pharmacy near you is open online with this map.

| Transportation

Evacuees can redeem a [free Uber ride](#) up to \$40 by applying the promo code "WILDFIRE25" in the Wallet section of their Uber app before requesting a ride to a designated shelter location. Shelter locations valid for free Uber rides:

- Pasadena Civic Auditorium – 300 E. Green St, Pasadena
- Westwood Recreation Center – 1350 S. Sepulveda Blvd., Los Angeles
- El Camino Real Charter High School – 5440 Valley Circle Blvd., Woodland Hills
- Ritchie Valens Recreation Center – 10736 Laurel Canyon Blvd, Pacoima

Each user can redeem up to two free trips through Jan. 15. Uber noted that driver earnings will not be affected by the promotion.

Evacuated residents who need a ride to a shelter can use the code "CAFIRERELIEF25" for a [free Lyft ride](#) worth up to \$25. Each user can use the code for two rides maximum.
